

Intergroup Meeting Minutes for January 6, 2010

Alex A. called the meeting to order at 6:15pm followed by the Serenity prayer and the reading of the 12 Traditions.

Welcome New Representatives: Lewis F -3rd Tradition Group, Lindsey H-Smoke Free Sobriety, Pat F-Happy Hour Group, Martina R -Women's Awakening,

Secretary's Report: David C. - Motion made accept minutes as printed in the Today. The question was discussed and agreed that all chairs where to be responsible for providing a written report to the secretary to be incorporated into the minutes. Housekeeping issues dealing with this should be addressed by officers.

Treasurer's Report: Henry M. Would like to thank all groups and volunteers for serving and supporting our annual Alcothon which netted \$829.53, 248.32 of which was contributed by AA groups who participated in the Alcothon held at the Triangle Club. Our total income for December was \$9914.01, expenses were \$8912.12 for an increase of 1001.89. We are currently below our \$24,000.00 3 month prudent reserve by roughly 18,700.00. Annual contributions have been steadily declining in the past 3 years from 2007 ~ 58,000.00, 2008 ~ 49,713.00, 2009 ~ 47,993.00. Our 2008 payroll tax issues are closer to resolution with the IRS.

Committee Reports:

- 1. General Service/Intergroup Liaison: Luiz C. Nothing to report this month.
 3. Office Manager: Beth E. All shift are filled and the office is running smoothly. Office is open again on Saturday staffed by a volunteer.
- 4. Public Information: Larry M. PI/CPC has been very busy. I dropped of literature at Palm Beach Count Substance Abuse Coalition, and the Pride DUI School on Congress Blvd. I discovered 2 AA literature racks at the DUI School and will be taking more literature back to them. I have coordinated young AA volunteers for the Feb 3rd Health Fair at the Florida Atlantic University Campus in Abacoa. Also I am putting together a panel of volunteers for a Re Entry Transition Fair on the 29 of January.
- 5. 12 Step List: Anthony M. The list is up to date and a copy will be provided to the Phone
- 6. Phone Volunteer: Lisa M. All permanent positions filled. We have a good amount of back-ups on the list at this time. Calls were dropped on Christmas Day - not passed on to next person by permanent volunteer. Calls were also not picked up on New Year's Eve Day - by permanent volunteer - back up had to be found to fill in last minute. New Year's Day calls where not passed on to the correct permanent volunteer. Suggestion made: training, question/answer seminar session be held - 1-2 hours on some Sunday - all permanent + back up volunteers attend. Lisa M willing to conduct the training, details for training sessions to be given at next Steering Committee meeting and to be announced at the next Intergroup Rep meeting
- 7. Today: Cheryl. I want to introduce myself to all the Reps. As the new today editor, and I am looking forward to serving you. If there are any events or announcements you would like to be in the Today, send them to the Intergroup office by the 3rd Wednesday of the month, also the Today sill have a "comedy Corner" joke section. - 10. Group Contact Committee: Steve Y. No written report was provided to secretary. "So far there is nothing new to report regarding the Group Contact info."
- 11. Bridging the Gap: Babs -absent, Bridging the gap is going well totals are as follows 77 bridges in 2008, 17 bridges in the month of December 2009 and 169 total bridges for the year of 2009. - 12. Ad-Hoc Committee for reviewing Intergroup By-Laws: Luiz C- Committee will be meeting during January to gather information about by-laws, and bring a suggestion of topics to be discussed by the groups regarding updating ours.
- 13. Ad-Hoc Committee for reviewing Moving Intergroup Location: Mark- Committee has meet twice to discuss the feasibility of moving Intergroup location and findings are as follows.
 - That the \$400 dollar rent is below market value and is in violation of AA Traditions
 - It is feasible that Intergroup move several location where found with squarer footages of 450 to 650 SF at a rent monthly of 400 to 650.
 - If we are to renew are lease we should request a fair market values for our rent and request all communication from the landlord be confined to our leasing agreement.

The committee is requesting a "sense of the meeting" to determine which direction the groups would like to focus on, decision must be made by Aprils meeting and as such the committee will bring recommendation to discuss in Februarys meeting and to vote on in March.
