**Intergroup Meeting Minutes for July 7th, 2010**

Alex A. called the meeting to order at 6:17pm followed by the Serenity prayer and the reading of the 12 Traditions.

**Welcome New Representatives:** Dan/Getting Started

**Vice Chair's Report: Steve Y.** It turned out that the Founder's Day Picnic was a success. We would like to thank all who volunteered their services. We also want to thank all the members of Palm Beach County who came and supported the event. It was a lot of fun and fellowship by all who attended. The operating report will be presented by our treasurer Henry M.

**Secretary's Report: Karen L.** - Motion made to accept minutes as printed in the Today. Passed

**Treasurer's Report: Henry M.** - Our monthly revenue for June 2010 was **\$11,777.52** with expenses being **\$10,941.92** leaving us with a surplus of **\$835.60**. By keeping our belts tight, support from groups and through service we were able to transfer **\$1640.00** into our Prudent Reserve (**the first since July of 2006**) making the current balance **\$3640.25** which leaves us below the **\$24,000.00** mark by **\$20,359.75**. In June of 2009 our income was **\$8741.32** and expenses were **\$10,415.79** leaving us with deficit of (**\$1674.47**). Our Prudent Reserve balance was **\$12,384.66** at that time, below the mark by **\$11,615.34**. Our Founder's Day Picnic was a great success, providing fellowship, food, and fun for nearly 200 attendees. Our total income was **\$3185.00** and expenses were **\$2909.00** leaving us with a surplus of **\$276.00** Thank you to all who volunteered and to all who participated. At the time of this report we are still awaiting for final figures as all ticket proceeds may not have been turned in.

**1. General Service/Intergroup Liaison: Maggie T.** - Absent

**2. Office Manager: Ed Bednarz** - We have openings for office volunteers for Friday 1 - 5 PM and Saturday (for the next three weeks only) from 9:30 - 1:30. We could also use back-up office volunteers for vacation coverage. The office volunteers sell literature, answer the phone and assist with any special projects. Remember it is summer and the activity is slow, so if you decided to volunteer bring a book or your laptop. We have a wireless router so you can have free internet access. Activity for June was 431 compared to 522 for May. June activity is broken down as follows: 178 meeting information calls, 10 - 12<sup>th</sup> Step requests, 2 Bridging the Gap requests, 19 requests for other program information, 1 request for public information, 1 request for institutions meetings, 214 visitors to the office, and 6 emails for meeting information or other information. 7. Have I paid enough attention to the book *Twelve Steps and Twelve Traditions*? To the pamphlet *AA Tradition—How It Developed*?

### From the Officers.....

A couple of issues have come before Intergroup from our western community groups. The first is the extended drive to the Intergroup office for these groups to get their respective supplies. It was suggested that we open a western office to support those groups. Though we do see this area growing in both groups and meetings, financially we are not in the position to do this as we still are struggling to keep our office financially secure. Maybe the answer would be to communicate with the other groups out west and set up a rotation of combined orders and each could take a turn coming to the office for all supplies needed each month. The Intergroup office would be happy to accept fax orders and have them available for pick up.

The other issue coming forward also involves our western groups. A number of hospitals, including Palms West, are changing their security procedures by requiring all visitors to present photo ID and will run all visitors for any outstanding warrants. If the visitor has warrants, then security will call police and have the visitor arrested. This of course would affect groups and members attending meetings inside the hospital. Members have contacted Intergroup seeking guidance and suggestions regarding Traditions and alternatives.

Anonymity is one of our most cherished principals both at the personal and public level. Many of us would not have attended our first meeting if we could not have remained anonymous. A.A. pamphlet "Understanding Anonymity" really spells this out and Bill W. in his last talk felt it so important as to be the only thing future generations should never change. Groups who continue to meet in these hospitals are free to do so. Intergroup does not "police" groups and every group has the right to practice the 12 Steps and 12 Traditions as their group conscience decides. This is very clear in our 4<sup>th</sup> Tradition. We feel at the Intergroup level we have the responsibility of informing members, especially the newcomer, of this anonymity break. This information should be available in the Where and When, the Intergroup web site, and at the Intergroup office.

Your participation is always needed. We are listening, but action ought to come from all of us.

Getting back into "real world" is not always easy for the alcoholic. Many of us had not been sober on the outside for a long time, and we admitted that the first days out were a little frightening. Sometimes, we did not know if we would stay sober. Even new members of A.A. usually know that they cannot make it alone. The dilemma for some us was that we were not sure we could make it in A.A. either. We said things like, "where will I find a meeting I can be comfortable in?" or "Who will be able to trust?" It was tempting to give in to "I won't fit in", or "I'm too different." Lots of alcoholics think like this; **we did.**
