



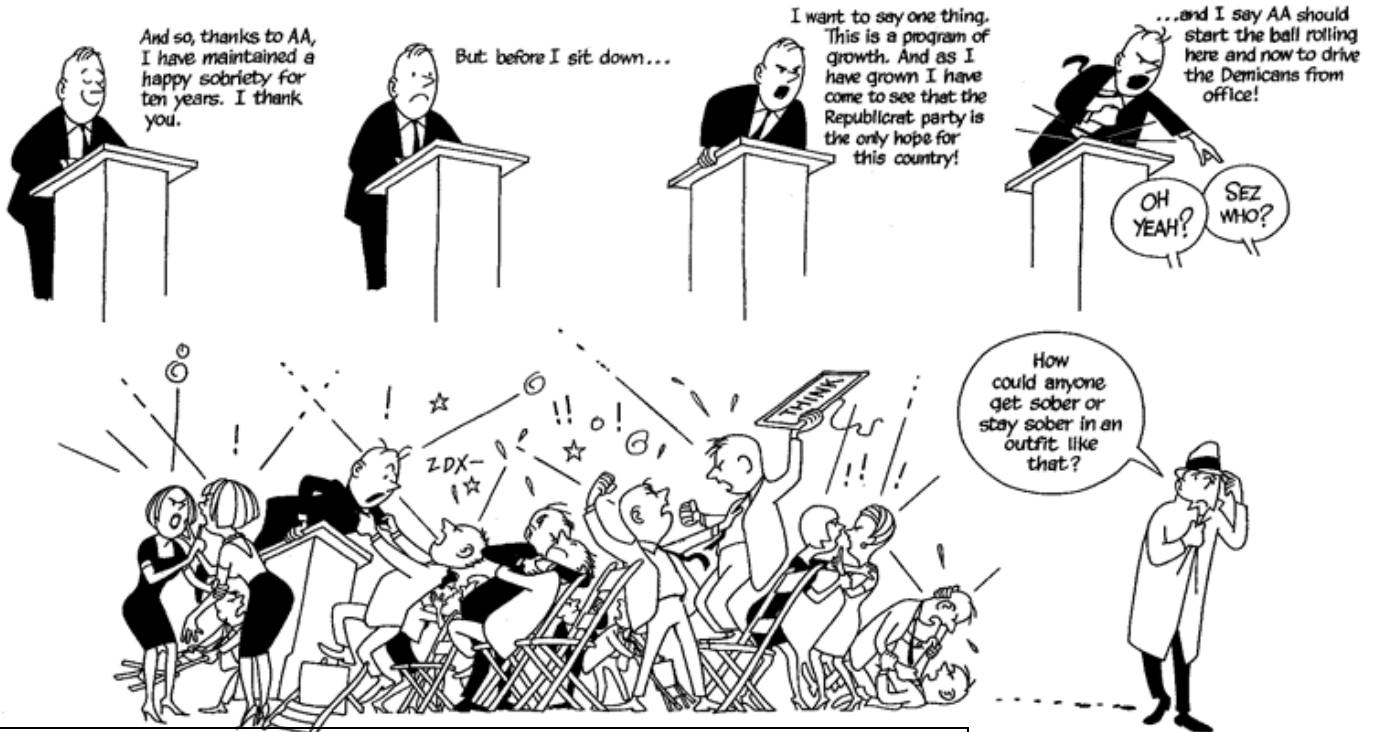

**Intergroup Meeting Minutes for September 8th, 2010**

Alex A. called the meeting to order at 6:15pm followed by the Serenity prayer and the reading of the 12 Traditions.

**Vice Chair's Report: Steve Y.** September 18<sup>th</sup>: 34<sup>th</sup> Annual Intergroup Potluck Dinner @ Finland House, 301 Central Blvd, Lantana, FL 33462. Dinner starts @ 6pm and speaker @ 7:45pm. Tickets are \$8 and please bring a covered dish. Guest speaker: Don P. from Naples, FL We are waiting a vote from the groups to see if they want to participate in this year's alcathons: Christmas Eve and New Years Eve, to be held at the Intergroup meeting room.

**Secretary's Report: Karen L.** - Absent

**Treasurer's Report: Henry M.** - Our monthly revenue for August 2010 was **\$8,420.70** with expenses being **\$7,489.09** leaving us with a surplus of **\$931.61** and a balance of **\$5,786.03** in our Operating Account. We were able to transfer **\$500.00** to The Prudent Reserve bringing our balance to **\$5,107.47**, still **\$18,892.53** below the **\$24,000.00** mark. In regards to our income, we have shown an increase each month since May 2010; this has been achieved only through prudence, service and the much appreciated support of the groups we serve. Group contributions were up **\$1,278.72** in comparison to August 2009. We would also like to extend a special "Thank You" to the AA members that contributed at the Memorial Service for Bob W. aka (Make Your Bed Bob), those contributions were forwarded to Intergroup. Our expenses have remained typical with the exception of **\$1,749.51** which is part of the cost to fund our Annual Potluck Supper. We have also sent another **\$500.00** to our friends at the IRS leaving our Payroll Tax Debt for Q4 2008 at roughly **\$1200.00**. Our revenue for August 2009 was **\$5,258.01** with expenses being **\$9,859.89** leaving a deficit of **(\$4,601.88)**. Lower group contributions and much greater payroll expenses including payroll tax liability were the main cause of this deficit. Our Prudent Reserve balance was **\$8,891.84** at that time.

**Committee Reports:**

**1. General Service/Intergroup Liaison: Larry M.** The only thing that passed was a motion by the Archives Committee which gave an amount not to exceed \$650.00 to send two individuals to the Archives workshop in Macon Georgia. This covers gas and room. Dave D and Sherwin are going with a possibility of our former delegate Pat.

**2. Office Manager: Ed Bednarz:** - All of the Office Volunteer shifts are currently filled, but we could always use back up volunteers, as people come and go. Volunteers sell literature, answer the phone and assist with any special projects. If you decide to volunteer you can bring your laptop. We have a wireless router so you will have free Internet access. The total office activity for August was 410 compared to 589 last year. Most of the decline in activity was in the areas of calls & emails for meeting information. Website visits for August were 1,991 compared to 1,647 visits a year ago. This is an increase of 344 visits. It would seem that the use of the online Meeting List and website information is becoming more popular. Despite the extremely hot weather and slow summer activity, we had a surplus of \$931.61. The Office hours are Monday to Friday 9 - 5, and Saturday 9:30 - 1:30. We have plenty of "Where & When's" for sale, as well as Conference Approved literature and pamphlets. If you would like to volunteer at the office, please call the Intergroup Office at 655-5700.

**4. 12 Step List: Nick F.** In August, I stated a need for women volunteers, who could make 12 step calls. At the September rep. meeting, a sign up sheet of 14 volunteers from the Free Spirited Women's group of PB.Gardens was given to me. Thank you ladies. The list will be updated. A need continues for Spanish and Creole speaking volunteers. I plan to be at the Potluck diner, with all the Committee Chairpersons.

**5. Phone Volunteer: - Luiz C.** - All positions are filled, and the back-up volunteers are being active on helping cover shifts on holidays and vacations. I would like to thank all volunteers for their service and help. **6. Today: Mark P-** In this issue I posted the July and August operating reports. This will keep the members more up to date with our finances. A reference to the new proposed by-laws is posted on the front page as well as an advertisement for the Friends of Bill W. Potluck Dinner.

**8-Day Club/Today: Pat D.** - There was only 1 new member for the month of August. 0 for Today's.

**8. Website Committee: Larry M.** - Uploaded proposed By-Laws and created links to it on Home Page and edited the services page. Edited home page.

**9. Group Contact Committee: Hugh H.** - Going to meetings, updating info and adding e-mail info

**10. Bridging the Gap: Ashley N.** - 7 Bridges for August. We need new brochures to be printed with the changes made and then we need to distribute to H&I.

**11. Institution Committee: Wendy** - Your Institutions Committee currently brings 108 meetings a week to 36 facilities, we had 16 new volunteers join in the month of September. There are still plenty of opportunities for all interested in this rewarding service work. We particularly need volunteers who are willing to go through the clearance process and take meetings into the county jail and state prisons. Plan to attend our regular meeting at the Triangle Club on Sunday, October 3rd, orientation at 4:30 pm followed by the full committee meeting at 5:00pm. New volunteers need to have six months of continuous sobriety and observe 2 meetings in facilities prior to active service. Hope to see you at our general meeting.

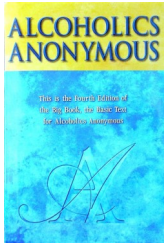

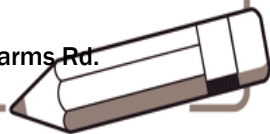

Getting back into "real world" is not always easy for the alcoholic. Many of us had not been sober on the outside for a long time, and we admitted that the first days out were a little frightening. Sometimes, we did not know if we would stay sober. Even new members of A.A. usually know that they cannot make it alone. The dilemma for some us was that we were not sure we could make it in A.A. either. We said things like, "where will I find a meeting I can be comfortable in?" or "Who will be able to trust?" It was tempting to give in to "I won't fit in", or "I'm too different." Lots of alcoholics think like this; **we did.**
