# INTERGROUP MEETING Intergroup Meeting March 9th, 2011

Call to Order: 6:17 Serenity Prayer Read 12 Traditions

Declaration of Unity: This we owe A.A.'s future: To place our common welfare first; to keep our fellowship united. For on A.A. unity depend our lives; and the lives of those to come.

Chairperson's Report: Alex A.: Tonight we will be conducting elections for all service positions. Due to the elections, all committee and liaison reports will be suspended. I have asked all the committees and liaisons to submit their reports to the Secretary and they will be published next month in the Today. If you or your group has a specific question for any of the Committees, please see that Committee Chair or one of the Officers after the meeting. As required by the new By-Laws, elections will be conducted by Third Legacy procedure and by written ballot. If you are attending this meeting as a guest or as an alternate group rep and your group rep is in attendance also, we request that you do not vote in tonight's elections. In the Spirit of Service and due to our new By-Laws being enacted this past January which suggest a year as a group rep to serve as a Committee Chair and an additional year as a Committee Chair to serve as an Officer, the Chair will seek a group census to "grandfather" the current Committee Chairs and Officers so they may stand for consideration to continue to serve Intergroup. Any Group representatives who have not served for the suggested one- year but desire to stand for consideration to serve as a Committee Chair, a group census will be taken on a case by case basis.

Welcome New Representatives: Ted/Westside Group, Judy/We Found The Way, Trish/Free Spirited Women, Alex/Third Tradition, Amy/Sober on Sunday, Kristin/Women in Sobriety & Cody/Lake Worth Group.

Vice Chair's Report: Steve Y.: The Spaghetti Dinner / Old timers Panel is now rescheduled for April 2, Saturday, from 6:00pm to 9:00pm still at the Finland House. The tickets are available through your Intergroup rep. as well as the Intergroup office and are \$10 each. In regards to our annual Founders Day picnic, we are looking to schedule it in June. date to be determined, and hopefully to have it up in Carlin Park.

Treasurer's Report: Henry M.: Total revenues for February, 2011 were \$7,524.65 and expenses were \$6,872.93 resulting in a surplus of \$651.72. Our Checking Account balance was \$3,092.47. We were able to transfer \$1500.00 into our Prudent Reserve Account. The Prudent Reserve balance is now \$12,042.23. This is below the Prudent Reserve requirement of \$22,200.00 by \$9,957.77. We sent a check to the South Palm Beach County Intergroup for \$870.49; so that each service entity would share the net surplus from the first Unity Breakfast of \$1,530.35. Our revenues in February, 2010 were \$8,713.37 and expenses were \$8,006.67 resulting in a surplus of \$706.70. Our Checking account balance was \$3,666.59 and our Prudent Reserve balance was \$2,000.07 at that time. Group Contributions this year were \$3,605.09 compared to \$3,614.96 in February, 2010. With a conscious effort to keep expenses to a minimum and exercising prudence with our operations, we have been able to maintain a course of steady improvement in a very tough financial climate. We would like to thank all of the groups and members for their continued participation and support.

Secretary's Report: (open) Karen L.: Accepted as posted in the Today.

Office Manager's Report: Ed B.: The total office activity for February was 504 compared to 764 last year; which was a decline of 260. Most of the decline was in the area meeting information calls & emails. The website visits for February 2,481. This is an increase of 469 over last year. The number of first time visitors was 2,069 and the return visitors were 412. The Intergroup Office hours are Monday to Friday 9 – 5, and Saturday 9:30 – 1:30. Pam announced that a group at FAU may be starting up and more will be revealed. Archives reported their February Meeting focused on preserving Grapevines and the committee is in need of old SCAAN's. They are also converting speaker cassettes to CD's. BTG had 1 call for the month. H&I reported all commitments were filled at this time. The Telephone Relay is in need of groups to man the hotline for June, July, & August. The Men's 12 Step Committee list has been updated. The meeting closed with the Lord's Prayer.

## **Tradition 4:**


Each group should be autonomous except in matters affecting other groups or A.A. as a whole.

### **Fourth Traditions Checklist**

- 1. Do I insist that there are only a few right ways of doing things in AA?
- 2. Does my group always consider the welfare of AA? Of nearby groups? Of loners in Alaska? Of Internationalists miles from port? Of a group in Rome or El Salvador?
- 3. Do I put down other members' behavior when it is different from mine, or do I learn from it?
- 4. Do I always bear in mind that, to those outsiders who know I'm in AA, I may to some extent represent our entire beloved fellowship?
- 5. Am I willing to help a newcomer go to any lengthshis lengths, not mine-to stay sober?
- 6. Do I share my knowledge of AA tools with other members who may not have heard of them?

## Concept IV:

Throughout our Conference structure, we need to maintain at all responsible levels a traditional "Right of Participation," taking care that each classification or group of our world servants shall be allowed a voting representation in reasonable proportion to the responsibility that each might discharge.
